



ADDO Canine Water Treadmill - Waiver and Release from Liability

I, the dog owner, knowingly and voluntarily enter into and agree to a waiver and release from liability for any injury that may result from the use of the canine water treadmill at A Dogs Day Out Springfield, LLC, (ADDO), 5425 Port Royal Road, Springfield, VA 22151. I understand and agree that this waiver and release from liability and assumption of risk applies to any physical, emotional, or psychological injury or illness of any kind whatsoever under any conditions that could result from the use of the canine water treadmill. I understand that ADDO does not offer veterinary care and that its staff members are not licensed as veterinarian technicians. The waiver, indemnification and release from liability applies to the landlord and owner of the facility as well as to the owners and staff of ADDO.

I agree that I am responsible for informing the staff of all pre-existing condition, injuries, sensitivities, fears and anxieties that their dog may have that might make use of the canine water treadmill risky for the dog. Any such condition must be clearly communicated to ADDO in writing on the ADDO Pet Profile. Each dog must have required immunizations listed on the Pet Profile and documentation from their Vet must be given to ADDO. ADDO reserves the right to refuse service to any dog that does not meet the requirements contained herein, or that in ADDO's sole discretion, appears to be uncomfortable in the canine water treadmill. The invalidity or unenforceability of any provision of the Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this Agreement, or of any other applications of such provision, as the case may be and such invalid or unenforceable provision shall be deemed not to be a part of this agreement.

For at least two hours before using the canine water treadmill, the dog owner must abstain from feeding their dog. Prior to entering ADDO, each dog must be walked outside the building, on-leash, allowing the dog to relieve themselves. All dogs must be kept on-leash at all times. Dog owners must cleanup if their dog relieves themselves, whether inside or outside of the building. Dog owners must comply with all ADDO canine water treadmill directions and regulations. ADDO staff will assist and instruct the owner on the use of the water treadmill and will be nearby during its use. The dog must be rinsed prior to entering the treadmill to remove all dirt and loose hair. Payment is required before entering the canine water treadmill area. To avoid being charged for a session, dog owners must cancel a scheduled appointment at least 24-hours before their dog's scheduled session. There are no refunds for missing a scheduled appointment for any other reason. There is a \$75.00 decontamination fee in the event that the dog urinates or defecates in the canine water treadmill, as this will force a delay for dogs scheduled for a session after your dog's session that day. The canine water treadmill is emptied and filtered after use by each dog.

I, the dog owner, choose to use the canine water treadmill equipment at my sole risk. If there is a dispute between ADDO and the dog owner, they agree to promptly confer in good faith to attempt to resolve the matter through mutual discussion, mediation or Alternative Dispute Resolution (ADR) procedures. If those attempts are unsuccessful, exclusive jurisdiction and venue shall be in the Fairfax County, Virginia courts under the laws of the Commonwealth of Virginia. The owner will reimburse ADDO for reasonable legal fees and costs.

If you do not understand or do not agree with these terms listed above, do not sign this agreement.
